BILLS PRESENTED IN THE LEGISLATIVE ASSEMBLY ON 16 NOVEMBER 2005

The following Bills were presented—

Roads (Amendment) Bill 2005:

The Roads Act 2002 (the “principal Act”) currently provides that the executive member may dedicate land that was an old road or an old service area as a public road or as part of a public road. The transitional period in the principal Act is due to expire on 27 February 2006. The Bill before the House amends the transitional provisions to provide a mechanism for the executive member to extend the transitional period to a later date or dates up to 26 February 2010.

Bail (Amendment) Bill 2005:

This Bill makes a number of technical amendments to the Bail Bill 2005 which was passed by the House at the October 2005 sitting.
